Both The Mission Adopt-A-Block Society (the "Society") and the individual or family adopting street(s) hereby commit to each other to perform certain activities for keeping neighborhoods in the District of Mission clean and safe. It is understood that while the objective of this program is to keep neighborhoods clean and safe, at no time is the safety of any Adopt-A-Block volunteer to be placed in jeopardy in order to participate in clean-up activities.

The Adoptor agrees to:

1. Remove litter along 2 blocks, or more, of municipal street(s) a minimum of twelve (12) times per year for a minimum of two (2) years on the street(s) sections designated below:

2. Assure that all participants are responsible individuals, and that persons under the age of 18 are provided with adult supervision. Discuss safety precautions with all participants and ensure that tools and safety supplies are provided for each volunteer. Wear safety vest and/or bright coloured clothing during clean-up activities.
3. Avoid contact with items that have the potential to be hazardous or cause injury. **DO NOT** pick up heavy or unyielding objects or items such as syringes, needles, used condoms and animal bodies.
4. Respect private property. Our focus is to clean and maintain our public right-of-ways.
5. Assist, when possible, to recruit new volunteers.
6. Receive and review Safety Handout. Sign the attached Release and Waiver Agreement in favor of the Society and Municipality.
7. **Notify Adopt-A-Block upon discontinuation of work and return equipment** (to be distributed to new volunteers).

Release and Waiver Agreement

Adopt-A-Block Program

By signing this document you waive certain rights including the right to sue. PLEASE READ CAREFULLY.
TO: THE CORPORATION OF THE DISTRICT OF MISSION, ITS OFFICERS, EMPLOYEES, DIRECTORS and VOLUNTEERS AND THE MISSION ADOPT-A-BLOCK SOCIETY (together called "THE RELEASEES").

ASSUMPTION OF RISK

I am aware that engaging in an Adopt-A-Block activity may involve certain risks, dangers and hazards, including, but not limited to picking up dangerous debris and collision with passing traffic. I agree to wear a safety vest and use proper tools (such as gloves, tongs and/or EZ Reachers) while participating to minimize any such risks and I freely accept, and fully understand and assume all risks and dangers and the possibility of personal injury, death, property damage or loss resulting therefrom including NEGLIGENCE, BREACH OF CONTRACT; OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT R.S.B.C. 1996, C.337 on the part of the Releasees.

RELEASE OF LIABILITY, WAIVER OF CLAIMS AND INDEMNITY AGREEMENT

By participating in the Adopt-A-Block program I hereby agree as follows:

1. TO WAIVE ANY AND ALL CLAIMS that I have or may in the future have against the Releasees.
2. TO RELEASE THE RELEASEES from any and all liability for any loss, damage, injury or expense that I may suffer or that my next of kin may suffer as a result of participating in the Adopt-A-Block program due to any cause whatsoever, including negligence on the part of the Releasees and including NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTORY OR OTHER DUTY OF CARE, INCLUDING ANY DUTY OF CARE OWED UNDER THE OCCUPIERS LIABILITY ACT R.S.B.C. 1996, C.337 on the part of the Releasees.
3. TO HOLD HARMLESS AND INDEMNIFY THE RELEASEES for any and all liability for any property damage or personal injury to any third party, resulting from my participation in the program.
4. This Release shall be effective and binding upon my heirs, next of kin, executors, administrators and assigns, in the event of my death.

I have read this Release prior to signing it and I understand its effect. I am aware that by signing this Release I am waiving certain legal rights which I or my heirs, next of kin, executors, administrators and assigns may otherwise have had against the RELEASEES.
